Coastal1 Credit Union is pleased to announce the **2024 Investing in Your Future College Scholarship** and its specifications. Coastal1 Credit Union will award ten (10) \$2,000 one-time scholarships to students starting their first year of college.

Requirements:

- Applicant must be a member of Coastal1 Credit Union.
 At least a custodial savings account in the applicant's name if a minor.
- Applicant must be a graduating high school senior.
- Applicant must be enrolled or accepted as a full-time student in a four-year college/university undergraduate program. Proof of acceptance/enrollment must be submitted with the application.
- Applications must be received by <u>Friday</u>, <u>April 5</u>, <u>2024</u>.
 Applications received after this date will not be considered.
- Coastal1 Credit Union employees and their children are not eligible.

Applicants must submit a strong word essay (500 words maximum) responding to the following:

What field are you interested in pursuing? How can you use the education in this field to make an impact/change in the world?

To apply, please submit the following:

- Completed application
- 350-500 word essay
- Proof of acceptance into college or a university undergraduate program. Please include a photocopy of the acceptance letter.
- List of extra-curricular or volunteer/community service activities.

Decision Process and Timeline:

- Applicants will be notified by June 2024.
- Recipients will be chosen by a panel of Coastal1 Credit Union employees.
